Update on Harmonised Standards Lists

What's changed in the recent lists published in the OJEU



Low Voltage Directive (2014/35/EU)

There has been one publication since the 2018 Issue 2 newsletter:

15th June 2018 2018/C 209/04

Note the date of withdrawal of current standards EN 60065:2014 and EN 60950-1:2006 (+amendments) has now been confirmed as 20th December 2020

However, EN 60065:2014 and EN 60950-1:2006 (+amendments) are not listed as Harmonised Standards (under the LVD) – probably an error.

Also, neither standard is listed under the Radio Equipment Directive

Radio Equipment Directive

The new "Guide to the Radio Equipment Directive 2014/53/EU" was published on the 5th June 2018, replacing the previous version of 19th May 2017.

This Guide brings together information previously available in several TCAM (EU Telecommunication Conformity Assessment and Market Surveillance Committee) documents and related Commission's websites. Based on the RED it does not duplicate what is already contained in the Blue Guide.

Registration, Evaluation, Authorisation and Restriction of **Chemicals (REACh)**

The European Chemicals Agency (ECHA) has added 10 new substances of very high concern (SVHCs) to the Candidate list.

• 27th June 2018 ED 61/2018

Substance name	Examples of use
Octamethylcyclotetrasiloxane	Used in washing and cleaning products, polishes and waxes and cosmetics and personal care products.
Decamethylcyclopentasiloxane	Used in washing and cleaning products, polishes and waxes, cosmetics and personal care products, textile treatment products and dyes.
Dodecamethylcyclohexasiloxane	Used in washing and cleaning products, polishes and waxes, cosmetics and personal care products.
Lead	Used in metals, welding and soldering products, metal surface treatment products, and polymers.
Disodium octaborate	Used in anti-freeze products, heat transfer fluids, lubricants and greases, and washing and cleaning products.
Benzo[ghi]perylene	Not registered under REACH. Normally not produced intentionally but rather occurs as a constituent or impurity in other substances.
Terphenyl hydrogenated	Used as a plastic additive, solvent, in coatings/inks, in adhesives and sealants, and heat transfer fluids.
Ethylenediamine	Used in adhesives and sealants, coating products, fillers, putties, plasters, modelling clay, pH regulators and water treatment products.
Benzene-1,2,4-tricarboxylic acid 1,2 anhydride	Used in the manufacture of esters and polymers.
Dicyclohexyl phthalate	Used in plastisol, PVC, rubber and plastic articles. A further use is also as a phlegmatiser and dispersing agent for formulations of organic peroxides.

Note: Lead is now restricted under REACh
